## Results of Vote of Asahi Kasei Corporation Shareholders

Results of shareholder votes at the 122nd Ordinary General Meeting of Shareholders of Asahi Kasei Corporation were as described below.

#### **Proposal 1** Election of Directors

### **Proposal 2** Election of Corporate Auditors

#### **Proposal 3** Election of Alternate Corporate Auditor
